## Overview: What are Omega-3 marine triglycerides

Omega-3 marine triglycerides are a family of "essential fats" that cannot be synthesise in our body. We must obtain them from our diet. Eicosapentaenoic acid (EPA), and docosahexaenoic acid (DHA) are called marine triglycerides and are found in fish and other seafoods. For people who do not eat adequate amounts of these foods, an omega-3 supplement may be recommended.

#### Interactions

Omega-3 marine triglycerides, the key ingredients contained in Kingsway Nutraceuticals *Omega 3 Salmon Oil 1000mg Soft Gel Capsules* have blood thinning effects and may interact other medicines such as anticoagulant medication e.g. Warfarin.

#### Nutritional considerations

Additional anti-oxidant support including vitamin E, C, Zinc and N-Acetylcysteine may need to be considered.

#### **Directions of use**

Omega-3 marine triglycerides are fairly well tolerated. Mild gastrointestinal discomfort may occur including reflux, heartburn, diarrhoea, nausea, fishy aftertaste.
